RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT

Awareness and Assumption of Risk

I am aware that involvement in the 2025 Stirling Santa Claus parade, whether as a participant or a volunteer, involves risks including risk of personal injury, death, property damage, expense and related loss, including loss of income. Included in these risks are negligence on the part of the Township of Stirling-Rawdon, its officers, volunteers and participants. I freely accept and fully assume all such risks and the possibility of personal injury, death, property damage, expense and related loss, including loss of income.

Release of Liability, Waiver of Claims and Indemnity Agreement

In consideration of the Stirling Santa Claus parade accepting my involvement as a participant or volunteer, I agree:

1. To waive any and all claims that I may have in future against the Stirling Santa Claus parade AND OTHERS.
2. To release the Stirling Santa Claus parade AND OTHERS from any and all liability for any personal injury, death, property damage, expense and related loss, including loss of income that I or my next of kin may suffer as a result of my involvement in this activity, due to any cause whatsoever, including negligence, breach of contract or breach of any statutory duty of care.
3. To hold harmless and indemnify the Stirling Santa Claus parade AND OTHERS from any and all liability for any damage to property of, or personal injury to, any third party, resulting from my participation in this activity.
4. That this agreement is binding on not only myself but my next of kin, heirs, executors, administrators and assigns.
5. The applicant hereby consents to public access of information provided for the purpose of marketing and advertising of this event.
6. The applicant hereby consents to distribution of photographs and/or videography taken during the planning and day of event for the purpose of marketing and/or advertising. The applicant also agrees to consent to media distribution for the purpose of public promotion.
